Agency Agreement

I wish Willen Hospice Ventures Limited to act as my agent in offering my goods for sale, at a charge of 5% commission plus VAT which shall be deducted from the proceeds of sale.

The goods that I am offering to Willen Hospice Ventures Limited are my own to give and do not belong to another household.

I am not acting as a business in bringing goods for sale into any Willen Hospice Ventures Limited shop.

I confirm that I am at least 18 years old and understand that this agency agreement is a legally binding contract.

I authorise Willen Hospice Ventures Limited to sell these goods in whatever manner it decides in order to maximise the value of the sale, and understand that if Willen Hospice Ventures Limited are unable to sell any of the goods they have the right to dispose of the goods as they see fit. I agree that Willen Hospice Ventures Limited will not be responsible for any loss or damage to any goods brought into the shops for sale.

As legal and beneficial owner of the goods until they are sold, I understand that I have the right to keep all of the net proceeds of the sale, but can choose to donate all or part of the proceeds, if I wish.

I understand that in the event of a purchaser returning my goods for a refund or exchange, Willen Hospice Ventures Limited will assume financial responsibility for this refund or exchange as appropriate.

I agree that Willen Hospice Ventures Limited will NOT write to me to confirm donations if the total value of the money raised, after the deduction of commission and VAT, (the net sales proceeds) from the sale of my goods in any tax year is equal to or less than £1,000, and the net sales proceeds will be treated as a donation to Willen Hospice Ventures Limited. I understand that Willen Hospice Ventures Limited WILL contact me if the net sales proceeds of my goods in any tax year is in excess of £1,000, detailing the net sales proceeds and the Gift Aid value to reclaim in that tax year. If Willen Hospice Ventures Limited does not receive a response from me within 21 calendar days of the date of this notification, it will be assumed that I consent to donate the net sales proceeds to Willen Hospice Ventures Limited, and Gift Aid will be claimed on this donation by Willen Hospice.

I understand that regardless of the amount raised from the sale of my goods, Willen Hospice Ventures Limited will notify me annually of the total value of sales achieved in a tax year and request that I contact them if I have not paid sufficient tax or if my contact details have changed. This statement will provide information that I may find useful in settling my tax position*. I understand that this statement will not allow me to request the net sales proceeds to be returned to me if these are under £1,000 in line with the above.

Either Willen Hospice Ventures Limited or I may terminate this agency agreement at any time.

Willen Hospice Ventures Limited may vary the terms of this agreement at any time by written notice to me.

Willen Hospice Ventures Limited (company number 2479448) is a wholly owned trading subsidiary of Willen Hospice (registered charity number 270194), and pays its profits to Willen Hospice (to the maximum amount permissible).
